Submission of an entry constitutes agreement with all the terms of the NAA shows. NAA will take a 20% commission on art sales & 14 Cedar Street will take a 15% commission on art sales. All sales will be processed through the NAA. NAA is not responsible for work not removed by pick-up date. Artist grants rights of use of images for publicity and website content. Website thumbnails are protected from enlargement. Please provide notification in advance if someone other than the artist will be picking up the artwork.
